Fellow AWBA/PVA Members:

As Tournament Director of the 6th Annual MSCPVA Invitational Tournament, I would like to invite you to participate in this year's event. The tournament will be held at **King Pin Lanes** in Colorado Springs, Colorado – August 12-15, 2010. All events except the Auxiliary tournament and Up/Down Event will be USBC & AWBA sanctioned. This is an AWBA/PVA National Bowling Tour Event.

I hope that you will consider attending. We will be including some special prizes that everyone will be eligible for. We will conduct several raffles and 50/50 drawings that will be held during the event. There will be an UP and DOWN No Tap event this year. Each team will consist of one wheelchair bowler and 3-4 standing bowlers. The UP and DOWN event helps recognize our sponsors and those volunteers that have financially supported our event. We NEED your participation as well to make it successful. Please sign up. It helps us financially provide for the event.

Doubles will be Pins-Over-Average. After three games the field will be cut to eight teams with head to head competition. Half of the remaining teams will be eliminated after each subsequent round.

We are using your AWBA adjusted tournament average or your current USBC book average, whichever is higher. HDCP will be 90% of 210 for A/B Divisional qualifying. In the handicap divisions, we will be bowling 15 games of qualification in singles followed by roll-offs for the top five finishers in all divisions. The Scratch Division will be match play. Roll-offs will commence 15 minutes after the final qualifying round of all divisions have concluded.

MSCPVA will not be securing a Tournament Hotel this year. For the past two years we have found that several hotels in the area have competitive rates with varied amenities. Therefore, we encourage you to go online to Google.com and type in Colorado Springs Hotels. You will find a variety of hotels in the area. The Tournament Committee will not be handling room reservations or making airport pick-ups. You should call to make your personal arrangements as soon as possible. There will not be any transportation provided from the hotel to the bowling center. So, please plan accordingly.
