The Mountain States Chapter of the Paralyzed Veterans of America is hosting its 6th Annual USBC/AWBC Sanctioned Wheelchair Bowling Tournament this summer. Our event will feature many disabled veterans from around the United States that will compete for prize money and awards.

We want you to participate!

On Friday night, August 12th at 7:00 pm; MSCPVA is hosting our “Up-Down” competition tournament.

This competition will consist of 4 person teams, comprised of one disabled bowler and three able-bodied bowlers. It is a fun 9-pin No-Tap (with handicap 90% of 210) format. Your most current league average will be used. Each team will bowl three games. For those bowling without an average, their average will be computed based upon the three games bowled at the event. Total team pins will determine the final standings.

This is a charitable event! In attempt to create a fair competition, a team of four individual's combined averages cannot exceed 780. So, if you're forming a team, please ensure that your team isn't comprised of all ringers or pros..... You can communicate with a local wheelchair bowler to add to your team, or the tournament committee will select one for you. Notably, averages of the competing disabled bowler's range from 100-200. So, allow for a little flexibility in your team average.

Prize money will be paid down to the top five finishing teams! Raffles and 50/50 drawings for prizes and cash will also be conducted during the event. If you are interested in competing or entering a team please contact MSCPVA at: 800-833-9400 or 303-597-0038. An entry form is attached.
